Since Fall 2022, the LHBS and Business Council have been collaborating to pursue different continuous improvement initiatives. During last month's meeting, Dean Raj Devasagayam and Chair Deb Clay shed light on the council's progress, specifically noting curricular advancement, student success, and faculty development.

Curricular Advancement: The curriculum review process began this past summer, requiring close collaboration among department chairs, faculty, administrators, and the Business Council Academic Support Committee. Student Success: The Business Council's Awards & Scholarships Committee has enhanced its 2023 Program by adding four new student awards, which recognize student leadership, community service, innovation & entrepreneurship, and resilience & resourcefulness, respectively. Pamela Scott-Johnson and Jeffrey Stapleton Discuss Transition to Colonial Athletic Association (CAA)

Provost & Senior Vice President of Academic Affairs Dr. Pamela Scott-Johnson and Director of Athletics Jeffrey Stapleton teamed up to present the University's transition to the Colonial Athletic Association (CAA), explaining how it supports the overall Monmouth University strategic plan. They informed the Business Council of several key drivers for this change, which support both the athletic program and curricular agenda.

Stapleton provided some background about the CAA; it consists of 13 private and public universities from Maine to South Carolina. The league is Division 1 and considered a "mid-major" sports conference. He also described the new conference as more competitive than the previous conference as the universities involved are of a more similar profile to Monmouth University. Although Monmouth is the second smallest by enrollment, our conviction to "punch above our weight" is brought to fruition in this conference. Likewise, joining the CAA allowed the sports programs to consolidate 23 of the 24 sports offered into one conference.

Both Stapleton and Dr. Scott-Johnson emphasized the strategic value of this conference. According to their presentation, the CAA was founded under five primary commitments: Academic Excellence, Competing at a Championship Level, Inclusive Excellence, Sustainability, and Well-Being.

This alliance brings Monmouth into the fold of a consortium of universities that collaborates to achieve mutually beneficial goals. It is governed by the provosts of each university, and they meet on a periodic basis to exchange information and discuss the relevant issues facing their respective universities. The program closed with a great discussion led by questions from Business Council members, during which time Dr. Scott-Johnson made it clear that Monmouth University does not only want to compete at a higher level; they want to WIN!

Career Development Team Highlights New Initiatives

Monmouth University's Career Development team updated the Business Council on how they are preparing students for successful transitions into careers of their choice. Executive Director Beth Ricca, Director of Employer Engagement Jeff Mass, and Outreach Coordinator Julia Angeliadis emphasized the importance of internships in employer recruiting.

Citing the National Association of Colleges & Employers Job Outlook 2023, 70% of interns are offered full-time positions at the company at which they interned. The team laid out their plans to make this statistic a larger reality at Monmouth, which involves the pilot of two new, employer-student programs.

Connecting Students to Employers: Career Development has engaged in a holistic effort to bring together students and employers. This includes Virtual Industry Fairs, Employer Information Sessions, and the 2023 Career & Internship Fair (October 4, 2023) which give students the opportunity to network directly with hiring teams and learn about opportunities across multiple industries. "Hawk Career Treks" and "Intern For A Day" are examples of Career Development's new programming, allowing students to work directly with professionals to better understand potential career paths, positions, and company culture.
