## DEPARTMENT PRESENTS RESEARCH AT THE ANNUAL MEETING OF THE AMERICAN SOCIETY OF CRIMINOLOGY



GRADUATE STUDENT SYDNEY STRICKLAND PRESENTS HER RESEARCH ON CIT TRAINING

On November 16, 2023, a group of researchers from the Department of Criminal Justice at Monmouth University presented their research findings at the Annual Meeting of the American Society of Criminology in Philadelphia, PA. Their work centered on the Crisis Intervention Team (CIT) training offered by the Monmouth County Prosecutor's Office to local law enforcement and mental health practitioners. The purpose of CIT training is to build collaboration between law enforcement and mental health providers and foster de-escalation skills with special populations to ultimately alleviate police involvement in crisis situations, divert individuals from the justice system, and decrease use of force. Dr. Meg Forney, Dr. Brian Lockwood, and graduate student Sydney Strickland each presented their work to evaluate the effectiveness of the CIT training in Monmouth County.

# DR. JOHN COMISKEY RECEIVES AWARD AS TOP HOMELAND SECURITY EDUCATOR IN 2024



## STUDENTS LEARN TO APPLY EMERGENCY MANAGEMENT AT 'SAFETY TOWN' WITH NJ NATURAL GAS

Students from Dr. Carey's Principles of Emergency Management (HLS 286) class visited the New Jersey Natural Gas training center known as 'Safety Town' in Howell, NJ during the Spring 2024 semester. Students were greeted and received a series of short classes on subjects ranging from chemistry, gas delivery systems, fracking, emergency response to gas leaks, and neighborhood evacuation protocols. Students observed volunteer firefighters battling a fire caused by a controlled gas leak and watched their evaluation process. The firefighters' performance was evaluated based their ability to apply what they learned in the classroom to the fire pit prior to the student's arrival. Next, students were taken to the Incident Command Tactical Headquarters Vehicle and received a class on its purpose and how NJ Natural Gas interacts with first responders during emergencies. Finally, students were taken inside the main facility to experience a series of scenarios first responders are likely to encounter during a gas leak or fire situation using virtual reality technology. Students received immediate feedback in how they handled select situations after a brief demonstration by our host.

Dr. Giuseppe Fazari presented at the Courthouse Security for Judicial Officers externship program included 16 hours of classroom instruction, as well as visitations to the Supreme Court of Ghana and Kwame Nkrumah Memorial Park and Museum. The purpose of the program was to provide a cohort of approximately 35 judges information about the general trends related to court security; provide a primer on conducting a security audit and developing a plan; present an overview of security considerations in judicial protection; provide guidance on crisis management and emergency planning related to high profile trials, hostage situations, and workplace violence.

### STUDENT INTERNSHIP EXPERIENCES

This past summer, I had the privilege of serving as an undergraduate intern with the New Jersey Office of the Public Defender's Monmouth County Office. During my employment, I had ample opportunity to gain hands-on experience in both the investigatory and legal fields. This was reflected in the work I conducted, whether it was handling subpoenas for upcoming trials or utilizing my written skills to draft in-depth evaluations of both media and paper discoveries. There were also numerous shadowing opportunities with active public defenders that included accompanying attorneys to detention hearings at the Monmouth County Correctional Institution and attending criminal trials at the Monmouth County Courthouse.

When reflecting on this summer internship experience, I am both grateful for the skill set I developed and saddened to part ways with the exceptional team of investigators and attorneys that I had the pleasure of meeting along the way. The NJOPD provided me with ample opportunities to grow independently in the criminal law field, as well as learn the value of courtroom etiquette and procedure. I truly look forward to applying these experiences to my future professional endeavors.

This summer, I was given the opportunity to intern at the Cumberland County Prosecutor's Office in Bridgeton, New Jersey. I worked with multiple units inside the prosecutor's office including the trial unit, the senior trial unit, the juvenile unit, and the domestic violence unit. My daily responsibilities included organizing case documents, taking notes during court proceedings, summarizing police reports, and writing up fact sheets. Also, I had the chance to sit in on special victims interviews and proofread legal documents. This experience gave me an inside look at the legal process, from pre-trial motions to sentencing, and gave me a stronger understanding of the duties and challenges involved in prosecutorial work. The value of my internship with the Cumberland County Prosecutor's Office was immeasurable. It deepened my understanding of the criminal justice system and sharpened my professional skills. By working with well-established prosecutors, I learned how to manage legal procedures, communicate effectively, and maintain confidentiality. The internship helped me build a professional network and also enhanced my confidence. Additionally, it made my career path clear, which encouraged me to think about law school as my next step. All things considered, this hands-on experience gave me a solid foundation for my future work in the field.
